

Official Contest Rules – 2021 Furnace Giveaway

The Prize(s)

One gas furnace installed at winner's privately-owned residential home. Does not include air conditioner, air handler, ductwork, or IAQ products.

Contest Dates

Submissions will be accepted starting September 13, 2021 at 9:00AM EST through October 17, 2021 at 11:59PM EST. The winner will be announced on October 28, 2021.

Contest Sponsors

To Qualify as A Contestant
